# **OBJECTS OF ASSOCIATION**

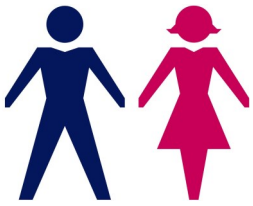
The 'Association' known as South Narrabeen Surf Life Saving Club, is a charitable community service based institution.

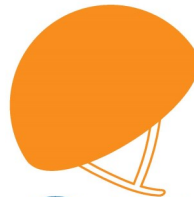
## **Club Objectives**

- To minimise the loss of life from drowning by carrying out surf patrols to render all aid possible to those in distress.
- To promote demonstrations and arrange classes of instruction in the principles of surf life saving and resuscitation.
- To encourage amateur sports, carnival competition, and social functions, etc. which do not interfere with the life saving duties of members.
- To foster youth development in a supportive family environment by providing education, competition and social activities for children.
- To enter into arrangements or contracts with any government, local government or other body for any of the purposes of the Club.
- To acquire or otherwise deal with land, buildings, leases, personal property, interests or rights with the object of furthering the interests of the Club.
- To carry on any other activities whatsoever calculated directly or indirectly to enhance further the interests of the Club such that profits are expended in furtherance of these Objectives only.
- To strive for governmental and public recognition of Surf Life Saving as the authority on aquatic safety.
- To promote the health and safety of members and users of the aquatic environment.

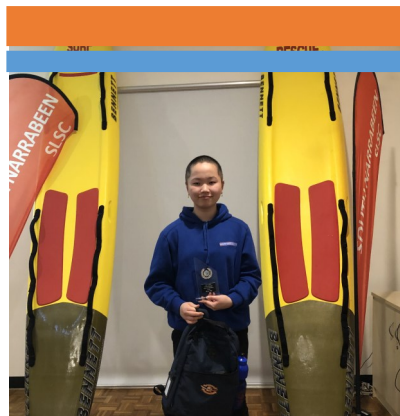

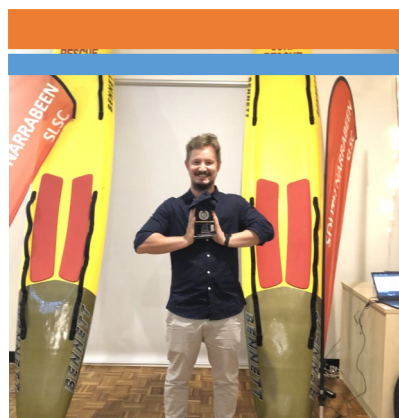

# ADMINISTRATION REPORT

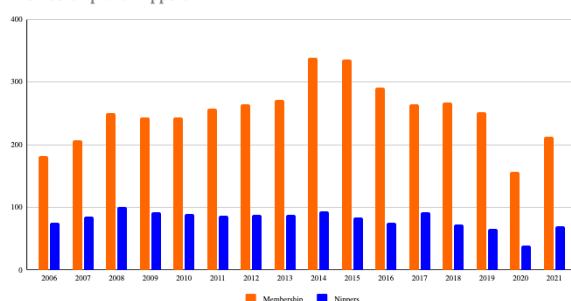

IT related capabilities were continued to be key focus from an Administration perspective. We have switched over to a new email platform based on Microsoft 365. This will support a number of important initiatives, including

- Significant increase in club electronic / digital storage
- Ability to access all emails and documents from any device.

# **FACILITIES REPORT**

This season we have taken a “deep breath” with the reconstruction of the club house. We have not done any major works, concentrating on repairs and maintenance.

The nippers have had a new kitchen installed, along with repairs to the balcony sliding doors. We also fitted extra Solar Panels to the building to help reduce our carbon footprint and also help reduce our running costs.

Northern Beaches Council has fitted Closed Circuit Television for the safety of our members and the community. Also, NBC are in the process of fitting Community WIFI to the club for all of the members and community to use.

Your Club along with the other surf clubs on the northern beaches has been negotiating with Northern Beaches Council for a new lease. These negotiations are in the final stages and then should be completed in July. We are then able to sign a new five-year sub-lease with Cabana Café.

The Collaroy to Narrabeen sea wall is slowly working its way towards to the club, with construction planned for the winter of 2023. The sea wall at South Narrabeen will slopping rock wall.

We are presently applying for a grant to construct a store room and office on the ground floor.

As we move into next season tenderers are being sought by NBC for the construction of the Training Room on the north, western balcony. This is the final stage of construction first commenced in 2016. Our clubhouse has certainly changed for the better in those five years.

My tenure as the Director of Facilities is due for reelection in July 2023 and I think it will be an opportune time for another member to take up the role. I am more than happy to discuss the role with anyone that is interested.

# **LIFESAVING REPORT**

I would like to say an incredibly big thank you to all patrollers for the season. It has definitely been a long season, particularly during the earlier parts of the season with COVID-19 and flooding. A particular thank you and farewell to patroller Chris Gale who patrolled nearly 400 hours over this season.

This year was also characterised by flooding where SNB was tasked with aiding the rescue recovery around areas of NSW when required. Thank you to all those who put their names down.

Whilst we had an overall peaceful season, we had two rescues that should be noted. First, we had the after-hour rescue on Australia Day by Chris Gale, Jeff Hewes, and nipper parent Damon Tudor who rescued a father and two children from a rip in the evening. The water was dangerous with strong currents and rips as well as a mass of seaweed. This rescue went on to be awarded SNB Branch's Rescue of the Month for January 2022.

Next, we have the IRB rescue conducted by Patrol 6, led by captain James Ryburn, who assisted the capsize of a small sailing vessel. IRB drivers Simon Learmouth and Marvin Smith led the rescue of the watercraft, supported by Collaroy and Narrabeen. In spite of a roaring South Easterly wind, Simon and Marvin ensured the safe return to shore of the vessel and 2 patients by towing them back to Fisherman's Beach.

We hope the patrollers get a well-deserved rest over the off-season and can't wait to see you in September!

# **FINANCE REPORT**

While the Covid-19 disruption continued well into the 2021-2022, it gives me great pleasure to report that our financial position continues to be very healthy.

In summary, the key Profit and Loss highlights were:

- A net profit for the year of \$5.6k, up \$48.9k on last year
- Total income of \$168.9k, up \$40.0k (31%) on last year
- Total expenses of \$163.3k, down \$8.9k (-5.1%) on last year

These results exclude the 2020-2021 facility development grant of \$229k, offset by the expense of \$229k for external work for which the grant was made, which would normally be reported in the Balance Sheet.

Income increased primarily due to: growth in memberships of \$6.5k (up 101.5%); donations and fundraising up \$6.3k (14.3%); Ocean View Room up \$28.3k (91.7%), including bar sales up \$19.8k (130.9%) and hall hire up \$6.8k (43%); sale of club equipment up \$2.2k (248%); Nippers BBQ up \$0.5k (35%) and clothing sales up \$3.5k (386%). Although reduced rent was provided to keep the Cabana café operating through lockdowns and restrictions, we received rent of \$31.0k, up \$4.8k (18%).

South Narrabeen SLSC is very grateful for the support of our individual, corporate and government sponsors, and I would like to acknowledge the following:

- Anna and Michael Petersons: \$100
- Network 10: \$10,000
- SLSNSW Grant for Covid Sport: \$1,000
- SLSNSW Grant Fundraising Distribution: \$6,100
- SLSNSW Grant for UAV storage: \$1,000
- SLISA Beach Safety Equipment Fund Grant: \$15,000
- Northern Beaches Council SLS Grant: \$6,842
- Australian Government Powering Communities Grant: \$9,900

Total expenses were \$163.3k, down \$8.9k on the previous season. Increased spend of \$1.5k on advertising, signs and banners was offset by a decrease of \$1.6k for photos, framing and scanning. Cleaning costs increased by \$3.3k, but gardening spend was down \$2.7k. Gym expenses were also down by \$2.7k. Furniture, fittings, signs and equipment increased by \$1.1k, insurance costs grew by \$1.3k while repairs and maintenance spend was \$3.9k up. IRB expenditure was \$1.6k higher, partially offset by \$1.4k less spent on the ATV. First aid purchases increased by \$1.0k, but savings of \$3.6k on SLS courses together with \$1.9k for patrol gear were realised. Nippers BBQ expenses and clothing purchases resulted in an additional spend of \$6.2k. In line with greater use of the Ocean View Room, drink purchases grew by \$8.6k to \$13.8k and the function manager expense increased significantly by \$14.0k to \$17.4k. Bar staff costs were included in the function manager line in the P&L, but were substantially offset by bar staff income from OVR customers.



# **FINANCE REPORT**

In summary, cash and cash equivalents increased from \$134.6k to \$164.6k, with a new additional term deposit of \$35k established. With current assets of \$170.4k far exceeding liabilities of \$14.4k, our position is strong. Net assets increased by \$5.6k. The club's equity position (members' funds) stands at \$480,605.

These strong financial results are generated by you: our members. I would like to sincerely thank everyone for their commitment, hard work and passion in helping South Narrabeen SLSC thrive, as well as those who reduced spend in line with budget during challenging times. Thanks also to the team at Fortuity for auditing our accounts. Finally, a special call-out to Greg Ritter, the previous Finance Director, for his expertise, ongoing guidance and unflinching willingness to help me in a new role.

Bring on Season 2022-23, and our 100 Year Anniversary! See you on the beach.

No significant change in the nature of these activities occurred during the financial year.



### Notes To The Financial Statements For The Financial Year Ended 30 April 2022

#### 1. Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Australian Charities and Not-for-profits Commission Act 2012*, the *Charitable Fundraising Act 1991* and associated regulations. The committee has determined that the association is not a reporting entity.

South Narrabeen Surf Life Saving Club Incorporated is an association registered under the *Associations Incorporations Act 2009* and domiciled in New South Wales.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

These are special purpose financial statements that have been prepared for the purpose of complying with the *Australian Charities and Not-for-profits Commissions Act 2012* and associated regulations. The Executive Committee have determined that the accounting policies adopted are appropriate to meet the needs of the members of the South Narrabeen Surf Life Saving Club Inc.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the AASB and the disclosure requirements of AASB 101 'Presentation of Financial Statements'; AASB 107 'Statement of Cash Flows'; AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors'; AASB 1048 'Interpretations of Standards'; AASB 1054 'Australian Additional Disclosures' as appropriate for not-for-profit oriented entities.

#### Accounting Policies

##### Revenue

Revenue is recognised when it is probable that the economic benefit will flow to the company and the revenue can be reliably measured.

##### *Sale of goods*

Sale of goods revenue is recognised at the point of sale, which is when the customer takes receipt of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract. Amounts disclosed as revenue are net of sales returns and discounts.

##### *Functions and Events*

Revenue from functions and events are recognised once the event is held in the Club facilities and has met its obligations to provide a venue for the expressed purpose agreed with the parties.

##### *Membership fees*

Revenue from membership fees is recognised at time of receipt.

##### *Grants and donations*

Grant & donation income is recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

##### *Interest*

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

**Inventories**

Inventories are measured at the lower of cost and net realisable value.

**Plant and Equipment / Surf Patrol Equipment**

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount and impairment losses are recognised in the profit or loss as revaluation decreases if the impairment losses relate to the revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

**Depreciation**

The depreciable amount of all fixed assets, including buildings and capitalised lease assets is depreciated on a straight line or diminishing-value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

<b>Class of Fixed Asset</b>	<b>Depreciation Rate</b>
Plant and Equipment	22.5%
Leasehold Improvements	10 - 22.5%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These gains or losses are recognised in profit or loss in the period which they arise. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

**Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

**Goods and Services Tax**

Revenues, expenses and assets recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included in other receivables or payables in the statement of financial position.

**Income Tax**

As the company is a charitable institution in the terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

**Trade and Other Payables**

Trade and other payables represent the liabilities for goods and services received by the company during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

**Comparative Figures**

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

**Critical Accounting Estimates and Judgements**

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.



# **SPONSORSHIP & GRANTS REPORT**

## **Sponsorship**

Key financial contribution was received from Channel 10, with whom we had managed to negotiate a sponsorship amount of AUD\$10,000 for the second season in a row. In return we have provided brand exposure through the club through our apparel, buntings and gazebos. Channel 10 was also acknowledged on our website. The partnership was scheduled to extend to Channel 10-led nipper activity. However due to staffing changes at their end, this did not come to fruition.

## **Grants**

We made 3 major grant applications during the course of this season:

### ***Powering Communities Program***

We were successful in securing the full amount of AUD\$9,000 offered with this program. Our basis for this application was for the installation of solar panels on our premises. The installation has been successfully completed on 13 January 2022..

### ***NSW Community Building Partnership***

This application was made at the cusp of the commencement of the 2021/2022 season, with a view for approvals coming through in November 2021. We were supported by the SLS Grants Unit with this process. Unfortunately our application was not successful in this instance. We are scheduled to make a follow up application for the upcoming season.

### ***Australia Day Community Grants***

Our application was made on the basis of community activities on club premises encompassing Bush 2 Beach, Circus On The Sand and the Club's own Australia Activities. However we were notified on 13 December that we were unsuccessful. It is uncertain whether funds for this grant were eventually disbursed, due to various Covid-related restrictions to public gatherings.

## **Sampling & Give-aways**

Sampling activity by EastCoast Beverages (juices) was conducted on 23 January 2022. This coincided with the sponsors conducting Nipper beach games and also prize give-aways. Approximately 120 bottles of juices were sampled on the day, and also given to the Club.

# **VALE**

## **BRIAN MALONEY**

From the mid 1940s to the mid 1950s, surf wizard Brian Maloney made a substantial contribution to the success of the Club just after WWII.

He first was noted in the 1945/46 season, winning the Club Junior Surf Championship with P. Major. Next season Brian was named the Most Improved Probationer. He gained his Bronze in the 1947/48 season and continued to compete in surf events, winning the Club's Senior Belt Championship and in the following season, represented the Club in its R&R team, winning a number of races in interclub competition. Their success was repeated in the 1948/49 and 1949/50 seasons. During this period Brian continued to be the Club's Surf and Senior Belt Champion in 1948/49 and in 1949/50. This season, Brian's skills and competence was recognised in his selection in the NSW State R&R team.

Always a respected member of South Narrabeen, Brian also served the Club as a Management Committee Member in 1950 and as Vice-Captain in 1951/52.

## **PETER O'REILLY**

Peter was an original "nipper" at South Narrabeen when the club first attempted to start nippers in the late 1960s. Peter being the son of our Life Governor Charles and his wife Pam.

Peter gained his Qualifying Certificate and was a good competitor at the club. He won a number of Club Championships, being a great board paddler.
