# SNSLSC Club Objectives

a.	The study and practice of surf life saving, resuscitation, and first aid to the apparently drowned and injured.
b.	To minimize the loss of life from drowning by carrying out surf patrols to render all aid possible to those in distress.
c.	To promote demonstrations and arrange classes of instruction in the principles of surf life saving and resuscitation.
d.	To encourage amateur sports, carnival competition, and social functions etc which do not interfere with the lifesaving duties of members.
e.	To foster youth development in a supportive family environment by providing educational, competition, and social activities for children.
f.	To enter into arrangements or contracts with any government, local government or other body for any of the purposes of the Club.
g.	To acquire or otherwise deal with land, buildings, leases, personal property, interests or rights with the object of furthering the interests of the Club.
h.	To carry on any other activities whatsoever calculated directly or indirectly to enhance further the interests of the Club, provided that any fundraising activity will be to the benefit of the Club such that profits are expended in furtherance of these Objects only.
i.	To strive for governmental and public recognition of Surf Life Saving as the authority on aquatic safety.
j.	To promote the health and safety of members and users of the aquatic environment.

This year our membership was 274 members and I list the member status below.



Finally, I would like to mention the support from Life Governor and esteemed Life Member Charles 'Chika' O'Reilly for his guidance on Club history and governance matters.



This funding has also been used to facilitate lifesavers from city and regional clubs to participate in the Lifesaving Exchange Program and covers the cost of the state- wide radio network, along with the provision of duty officer training and support.











### Finance Report

It gives me great pleasure to present the financial statements of South Narrabeen SLSC for the year ended 30<sup>th</sup> April 2014.

#### Financial Summary

The Club has posted a steady surplus for the year of \$28,321.85 before depreciation, this is despite a noticeable easing in sponsorships and donations as businesses and individuals become more prudent in the current economic environment.

Financial highlights for the year appearing in this year's results are:

Capital Investments Plant and Equipment - \$33,936.69. Previous Year \$30,070.81

This year the Committee continued to invest heavily into the future of the Club and its members. The areas where investment occurred were, Life saving \$4,736, Gym \$1,631, Competition \$8,339, Leasehold Improvements \$19,230.

Donations, Grants and Gifts – \$42,455.03. Previous Year \$47,641.70

The generous support of our sponsors must again be recognised, particularly the Sands Hotel, Gotcha Covered, M.S. Interiors, Minister for Police and Emergency Services, SLS NSW for the continued support in running the state-wide Raffle and Guardians of the Surf fundraising programs, Warringah Council.

Continued thanks must also go the private individuals, businesses and organisations who made donations and in-kind sponsorships during the year. If I can refer you to the Profit and Loss notes for the list of names.

A special thank you to Martin Thompson of Wong and Mayes Chartered Accountants for auditing our accounts and Bob Buckingham of Alan Hall Business Advisers for their assistance with the ATO and accounting advice.

#### Changes in Accounting

In an endeavour to respond to the feedback from the general members at last year's AGM an opportunity arose for the Club to increase its income whilst utilising the assets of the Club.

On the 12<sup>th</sup> January we registered the company of "S.N. Jaffa Pty Ltd" trading as the "Terrazza Beach Cafe". The sole purpose of the company is to run a kiosk /cafe business which would be at arm's length, from the running of the Surf Life Saving business. The company has two directors and one shareholder (SNSLSC) it is registered for GST and is a subsidiary of SN. It's run by two members of the Club to which there is a Management Agreement in place. Council has inspected the premises issued permits to allow trading. Further, the setting up of the business has gone through a consultative process with Chartered Accountants, Alan Hall and Partners.

As you can see from the consolidated accounts it is still in its infancy and there are issues to be resolved, but on the whole the Committee is confident of it being a success and a wonderful asset for the Club and the community.

## Clubhouse Report

This has been another great successful season at South Narrabeen. Once again we have seen the club progress further with improvements to the building following long term plans. The area we have available has been utilised by the members to its full potential and it looks like we are running out of usable space to cater for our ever increasing membership. There has been a lot of effort in the gym to get it set up and the results are fantastic, as soon as we build the western storage room we will be able to extend the gym creating more room.

The Ocean View Room Committee has done a wonderful job organising the kiosk which is not only a great asset for the club, it has proved to be something that the entire community can utilise and has provided a much needed revenue stream for the club. They have also restructured the management of the Ocean View Room which has proven successful with an immediate financial gain for the club, the Ocean View Room Committee has also given recommendations to the committee for improvements to the first floor area.

There were a few members willing to volunteer their time over the season to help with building projects around the club, I would like to thank everyone who helped out as most of your efforts go unrecognised and unrewarded, one member in particular that has done a lot of work in the background is Mick Haven, I'm sure we all appreciate the countless hours that Mick has put in this season making repairs and improvements throughout the club. I would also like to thank the rowers who have done a great job in keeping the boat area clean, the boat area has always been a bit of a sore point with the lack of storage space and this year in particular they have made a great effort in making sure that the equipment is put away properly.



During the off season we will be doing some work around the club which will include upgrading the main kitchen and constructing the store room on the western balcony area, part of the store room area will eventually house the lift to give access from the ground floor to the first floor, the lift is being funded by Warringah Council and the delay in it being installed is due to Warringah Council not being able to fund the installation. Hopefully they will have enough money next financial year and we can get the lift that we have been waiting for over the past four years.



Other work that we are looking at is a members area on the western balcony, Gymnasium extension, Members BBQ Area, Kiosk balcony awning, Eastern balcony awning, Level and returf lawn area (N/E side). Funding for some work is immediately available from Government grants that we have received and other work will be approved when funds are available. Hopefully over the next few seasons we don't lose the momentum we have seen over the past years and continue to create a club that is beneficial to all members and the community.

## Building and Development Report

As our Surf Club increases membership the cost of running the Surf Club increases. These increases in the running of the Surf Club include electricity, repairs and maintenance of the building, insurance, lifesaving awards and surf sports to name a few. The Surf Club committee did not want raise membership fees as they are well aware the time our

volunteers put into the Surf Club.

This season in an effort to diversify and increase income streams to help relieve some of these costs the Surf Club Committee appointed a committee to manage the 1<sup>st</sup> Floor of the surf club this includes the club room and the Ocean View Room.

The 1<sup>st</sup> Floor committee made a number of strategic recommendations to the club committee to assist in raising the profitability of the 1<sup>st</sup> floor. The recommendations are divided up into short and long term business strategies.



The short term business strategies are focused on lowering the expenditure and maintaining the income of the Ocean View Room. These short term strategies included using more volunteers in managing the Ocean View Room contracting the cleaning to a professional cleaner, reducing stock levels, upgrading the beach side of the club grassed area to encourage members of our local community to use the area.

Long term business strategies are focused on increasing the clubs income for the future of the club. Building the store room and training room, upgrade the kitchen including a new exhaust system, hand washing facility, and upgrade the grease arrestor and renovating the club room into the Terrazza Café to diversify our income streams and encourage our local community to use the facility and to help increase membership.

The business model used for the Café is standard business practise that is used by a number of Surf Clubs on the Northern Beaches and it allows the Café to operate focused on increasing business. The 1st Floor committee has been working with Warringah Council and the Council inspected the premises and issued a certificate of compliance with the Food Standards Code and Food Act 2003 to operate also we have Development Application with council to further upgrade the Café.



It has been fantastic to see the increase in community use of South Narrabeen SLSC; this is intangible, it is extremely positive and helps our Club become more profitable.

## Surf Sports Report

Six boat crews – 26 rowers – without doubt our largest group of competitive rowers representing South Narrabeen if not ever for at least a very long time. Lots of hard training and many trips to surf carnivals all over the country made this a very busy season.

We had crews competing in the Open Woman's (Stingers), Open Reserves (Smokey's), U/23 Men (Wood Ducks and Prowlers), U/23 Woman (Shovels), U/19 Men (Streakers). With some most crews being very competitive on a weekly basis.

Our great sponsors were on board again this year – The Sands Hotel (Clint) – MS Interiors (Simon) and Signature Blinds and Shutters (Nigel). Their support is greatly appreciated and long may it continue. We also need to thank Kone and Athletics 8 who supported two of our crews in the purchase of two new sets of oars.

The first carnival of the year was in Surfers paradise and the last carnival of the year, being the Australian Titles, were held in Perth, so we truly travelled all over the country to

compete this year, a lot of the time at our own cost.

Not only do the rowers compete and train in their spare time, they are also required to complete numerous patrols throughout the season. The rowing group are an integral part of the competitive side of the club but also dedicated surf lifesavers, which is a credit to all of you.

There were numerous highlights during the year however the two that stand out are; For the first time South Narrabeen were able to enter a boat relay (Junior Crew / Female Crew / Mens Crew) at the Branch



Championships where we finished a very credible fourth in the final against much larger clubs. An excellent result for the club and well done to the Streakers, Stingers and Smokey's for their efforts.

The second highlight was seeing three of our six crews rowing on the Sunday at the Australian titles. Many clubs were lucky to have one crew get through to the Sunday, to have three was a fantastic effort. All three crews making then last 12 in the country from some quality fields. Well


