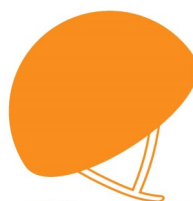
Club Objectives

- To minimise the loss of life from drowning by carrying out surf patrols to render all aid possible to those in distress.
- To promote demonstrations and arrange classes of instruction in the principles of surf life saving and resuscitation.
- To encourage amateur sports, carnival competition, and social functions, etc which do not interfere with the life saving duties of members.
- To foster youth development in a supportive family environment by providing education, competition and social activities for children.
- To enter into arrangements or contracts with any government, local government or other body for any of the purposes of the Club.
- To acquire or otherwise deal with land, buildings, leases, personal property, interests or rights with the object of furthering the interests of the Club.
- To carry on any other activities whatsoever calculated directly or indirectly to enhance further the interests of the Club such that profits are expended in furtherance of these Objectives only.
- To strive for governmental and public recognition of Surf Life Saving as the authority on aquatic safety.
- To promote the health and safety of members and users of the aquatic environment.

PRESIDENT'S REPORT

It has really been a significant year for us in many ways. In 2017 we celebrated our 95th anniversary and held a dinner in March 2018 which was well attended by members, old and new.

We have fulfilled our Lifesaving commitment with another year of 'No lives lost'. Whilst our patrol numbers are slightly lower over last season we contributed more hours patrolling the beach. This despite significant pressure on our nine patrol teams, to each member of our patrols teams, on behalf of your Club and Community I would like to say thank you and job well done.

Club membership had a slight increase over last season, but we saw the biggest increase in Nippers membership in a decade. We had 91 registered Nippers which consisted of more than 20 new families joining the Club. Thank everyone on our Nippers Committee for their hard work in making South Narrabeen such a welcoming, safe and inclusive Club to be a part of.

One of the best Financial position we have seen. Income up, expenses steady and helped by;

- the OVR bookings well up and reached new cost efficiencies
- Cabana Beach Kiosk enjoying strong patronage and was recently filmed for a Getaway episode
- Success in Grants

This now gives us the opportunity to buy new sports equipment, such as replacing the surf skis, providing a greater variety of surf sports which builds our Club's skills and then opens up competition opportunities.

Though a greater partnership with the Council we have secured DA approvals to expand facilities and upgrade the club with improvements like an awning over that balcony and replacing these stairs with a much more efficient flight of stairs which will also provide disability access to the cafe.

This season I was involved in a number of Committees to further the Club's development and I thank all the Members who contributed so much of their time to the various tasks

Building Sub Committee

Some of the most significant steps forward has been achieved by this Sub Committee in particular Life Member Tony Haven AM Life Member has been unrelenting in securing a commitment and support from Council in the continued upgrade of our building. And 2 milestones were recently reached in this endeavour :

Rescue of the Year

Patrol 9 - Samuel Warner (Captain), Simon Learmonth , Poppy Beckett, James Ryburn

Late on Saturday 17th February Patrol 9 were beginning to pack up after an otherwise quiet patrol. With the large swell produced by Cyclone Gita hammering the Narrabeen shoreline, the beach had been closed all day. A few hundred metres up the beach a member of the public began signalling the patrol frantically. He had just pulled an exhausted body boarder from the water in front of Marquesas apartments.

Sam who was the Patrol Captain jumped in the ATV with the on-duty Life Guard. The casualty had swallowed a lot of water, was exhausted and barely conscious. They pulled him above the high-tide line, rolled him into the recovery position, and administered oxygen. SurfCom was radio'ed to request an ambulance which Poppy waited for at street level. Simon stationed himself back at the club to continue monitoring conditions and be available for further support.

The paramedics arrived a few minutes later. After assessing the casualty he strapped onto a spinal board, and carried him to the ambulance stretcher. He was taken to Mona Vale hospital for further assessment, checked out later that evening and has made a full recovery.

ADMINISTRATION REPORT

The South Narrabeen Surf Life Saving Club committee met 12 times from July 2017 to June 2018. Meetings were generally held on the 2nd Tuesday of each month at a new time of 6.30pm with all members welcome to attend. Our meetings last approximately two hours and on average eight out of 8 Directors attended each meeting.

The main function of the committee is determining strategic goals and direction for our Club and to ensure that our strategic direction remains both appropriate and achievable. We also monitor organisational performance and ensure financial viability and security of our Club by setting financial governance

Our meetings were strategically based with each Director assigned actions to complete before our next meeting. Ongoing focus during committee meetings this session has been on Lifesaving and ensuring we as are meeting our patrol commitments.

BUILDING REPORT

It gives me great pleasure to report on the works that have been happening this season on the clubhouse and immediate surrounds.

Presently we have being assessed by Council two Modifications to building works and one Development Application; these can be viewed on Northern Beaches Council website.

DA2018/0446

Proposed Development.

First Floor.

Alterations and additions to existing first floor level to provide for enclosure of existing northern balcony to accommodate new training room, new balcony and external access stairs, extension of existing first floor balcony with new external access stairs and new Danaplon roof to eastern balcony.

External Works.

- Widen existing driveway.
- Relocate existing car space to the west of car parking

The proposal will see the removal of the existing observation tower, and therefore will substantially reduce the overall height of the dwelling. The proposed new portion of roof which will accommodate the new training room is sited below the existing ridge height of the building. These works will also include new stairs replacing the existing stairs on the eastern side of the dwelling.

Mod 2018/0165

Section 96 (1a) Minor Environmental impact-Modification of Development Consent DA2010/1843 granted for Alterations and additions to Surf Life Saving Club South Narrabeen.

The Section 96 Proposal is for the alterations to the existing works that comprise the installation of a new lift to ensure compliance with the Disability Discrimination Act, associated changes to the front foyer at the ground floor, construction of a new foyer extension to the front line of the existing building and the installation of a lift to allow vertical movement for persons in wheelchairs from the ground floor to the first floor of the building.

Mod 2018/0189.

Section 96 (2) Environmental Impact-Use of premises as a restaurant café. Review DA 2014/0636 conditions outdoor terrace Hours of Operation on trial period.

Modification of consent to remove condition 14, of DA2014/0636 relating to the trial period of 12 months for the use of the outdoor terrace.

The proposed hours of operation of both Café and the outdoor terrace are to be;

- Monday, Tuesday, Wednesday 7.00am – 4.00pm
- Thursday 7am-9.00pm
- Friday, Saturday 7.00am-10pm
- Sunday 7.00am – 9.00pm.

The Installation for the lift is fully funded by a grant from the NSW government and the works should commence in the second half of the current year.

The Mod for the hours of the café will confirm the hours of operation after a trial period.

Presently the DA with the DA works the awning on the eastern balcony we have been given a \$20,000 grant for these works. The removal of the observation and replacing the existing stairs are unfunded. Your Committee is presently working on application to fund these works.

As you can see in my report we have been extremely busy preparing and submitting application to bring our club house up to a suitable standard that we the members and the community can have greater utilisation.

Developing our club into a hub for the our members and the local community to have greater access to and use of.

In closing I would like to thank my fellow Directors for their support and help on these projects, never before has South Narrabeen SLSC had three Development Applications in progress. I would also like to thank Torch for his assistance in doing the “leg work” assisting me this season.

FINANCE REPORT

It gives me great pleasure to present the financial statements of South Narrabeen SLSC for the year ended 30th April 2018.

The following were the highlights

Operating surplus for the year was \$15,775.55. This is an increase of \$15,625 over the previous year.

Kiosk/Cafe

The club received a total of \$27,354 in kiosk rental income. This is a tremendous source of income and in-line with the Committee's and the sub-committees master plan.

I'd also like to take the opportunity of welcoming Katia Morosi proprietor of the Cabana Beach Kiosk. Katia brings with her a European cuisine, a flamboyant personality and business acumen.

On behalf of the Committee we wish her all the very best. Please contact Katia, should you have a special event, party, or engagement/wedding.

Donors and Grants

A full list of all donors, sponsors, grant income and gift income is included in the detailed income statement

Significant contributions included

- Stronger Communities Programme. This year we were lucky enough to receive \$7,000 which went towards the purchase of a new Can-Am Defender ATV \$18,836.
- Beach Safety and Equipment Grant. An initiative introduced by Government in 2014 whereby each Surf Club received \$5,000 over a five year term, funds must go towards the purchase of Life Saving Equipment. This year we received (\$10,000) so ending this grant agreement.
- Office of Sport. We were successful in receiving a \$1,250 grant under the 2017-2018 Local Sport Defibrillator Grant program. The Defibrillator is to be mounted upstairs in the OVR.

Other Income Highlights

- Membership subscriptions held steady
- Hall hire was up 28% on previous year and continues to be the club's major source of income. This year's surplus \$40,948.
- Kiosk income. In its inaugural year, rent equalled \$27,354.
- Golf Day in its third year raised \$2,004. Special thanks to Sarah and Matt Oaten.
- Club BBQ \$3,253

The Club is in a sound financial position with cash on hand of \$122,946 an increase over previous year of 63% or \$47,538.

The Club has total Assets of \$522,685 and liabilities of \$20,528 which is a combination of outstanding GST and utility payments which are cleared in the normal course of business. The Club's equity position stands at a strong level of \$502,156.





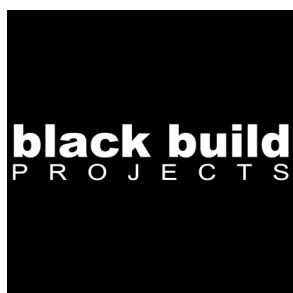
