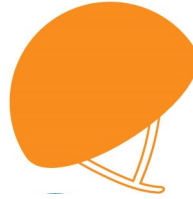
## **Club Objectives**

- To enter into arrangements or contracts with any government, local government or other body for any of the purposes of the Club.
- To acquire or otherwise deal with land, buildings, leases, personal property, interests or rights with the object of furthering the interests of the Club.
- To carry on any other activities whatsoever calculated directly or indirectly to enhance further the interests of the Club such that profits are expended in furtherance of these Objectives only.
- To strive for governmental and public recognition of Surf Life Saving as the authority on aquatic safety.
- To promote the health and safety of members and users of the aquatic environment.

# PRESIDENT'S REPORT

This season it seems we have had everything thrown at us. In September, what could have been a grand Club opening, was impacted by the last phase of the front construction works . Then large swells wiped out our beach on several occasions closing the beach and preventing the ATV safe access. Then the drought, fires and the flooding in Narrabeen was followed by the Covid 19 closure which prematurely stopped all operations, meetings and events .

However, despite these challenges our Patrol's did not miss a beat and beach attendance remained consistent throughout the season. As luck would have it, we had some of the best beach , water and weather conditions in the latter part of the season while we were unfortunately in Covid isolation.

We have fulfilled our Lifesaving commitment with another year of 'No lives lost'. Our patrol numbers stabilised and we continued to contributed more hours per patroller than other Clubs . We are indebted to the 7 Patrol teams. And to each member of our Patrols teams, on behalf of your Club and Community I would like to say thank you for a job well done.

Club membership was 198 members and we 66 Nippers registered. Thanks to everyone on our Nippers Committee for their hard work in making South Narrabeen such a welcoming, safe and inclusive Club to be a part of.

This season I was involved in a number of Committees to further the Club's development and I thank all the Members who contributed so much of their time to the various tasks.

## Building Sub Committee

This Sub Committee has again worked tirelessly, in particular Life Member Tony Haven AM and Honour Blazer Member Charles Longley have spent many hours in the continued upgrade of our building. This has been no small task.

And now 2 out of 5 major building works have been completed and the 3rd will be completed in September.

- Independent Director for Grants and Sponsorship: **Ken Passmore** and Patroller thanks for your participation in the Committee.

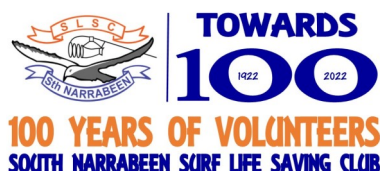

# **BUILDING REPORT**

This season has been a season of building and renovation. The building of the new Foyer and Disabled elevator were completed along with the external painting of the club also the upgrading of the car park.

We have now received the part Occupation Certificate for the balcony awning with the second part due for construction in 2020.

The completion of the new foyer and the disabled elevator has certainly been a long term project commenced in 2010 when Peter Madden was the Director Building Works. The design needed to be changed due changes in the regulations around disabled elevators. A section 96 application was approved by Northern Beaches Council for changes to the design.

Extra funding was also sought from Northern Beaches Council and this was provided by Council. Works commenced in April 2019 and completed in December. The new foyer has defiantly added a new look to the “shop front” of South Narrabeen SLSC.

With the completion of the foyer a new trophy cabinet was also constructed. Your Committee has started to invest money in our memorabilia including photos of our Life Members and Presidents.

During the winter Northern Beaches Council completely remodelled the car park and provided over twenty car parking spaces for visitors and six car parks for patrolling members. This is a major improvement of the facility.

Council also undertook the external painting of the club this along with the new signage on the clubs stands us out from other dwellings in the area.

At the end of the season the Ocean View Room was painted internally, the parquetry floor was repaired and sanded. In the bar area the floor was replaced along with the cool room and fridges.

Over the next two years we are building a Training Room/Museum, this will allow the club to further expand on displaying our history and also revamping the beach side access stairs for improved access to the Café.

The other large part in the jig saw is the construction of the sea wall from Collaroy to Goodwin Street Narrabeen. This will have a major impact on the beach and also the layout of the park in front of the club.

Your Committee is investing money in conceptual drawings how the park will look when finished. The concept will include a larger grassed area, improved access to the beach with steps and a ramp, more shade and more seating. This will provide to the members and community an enhanced area to unwind and relax.

# Stage 1 & 2—Building Completion

On November 17 we opened the doors to the new South Narrabeen SLSC and to say thank you and celebrate the completion of stage 1 of our building program (including installation of a new lift, Club Entry foyer and the resurfacing / re-configuration of the carpark).

In 3 years South Narrabeen SLSC will celebrate its 100th year of service. Over all these years we have responsibly and successfully managed the safety on our beach and seen 1000's of volunteers pass through our doors enriching their lives and breathing life into the club.

The last major renovation of this Club and car park was 44 years ago in 1975. Then the original club building was rebuilt after the 1974 storms and moved west towards Pittwater road with the loss of a number of car spaces.

Our goal is to build a thriving Surf Life Saving Club within an active community space and to do this we must ensure we strive to create an attractive, functional and accessible space for the future. We have to imagine what this 40 year old building could look like for the next generation of volunteers who will replace us so that many can continue to enjoy this facility and allow the Club to fulfill its role as a vital link in the SLSA network and in particular continue to encourage volunteers participation.

To achieve this the Club Committee & volunteers undertook a major planning process focusing on two key outcomes:

1. Increase visitors....by converting a members room to a Café and
2. modernise the facility ...to attract the community.

As the Building and Land is owned by Northern Beaches Council we needed their full support and to partner with them to combine our vision and Councils expertise, our passion and their know how to make it happen.

Overall we believe these works were overdue and look forward to it being a key landmark in the Narrabeen Community for many years to come.

- Number of Rescues – 6 (Rescue tube 3, Rescue Board 3)
- Number of Preventions – 1,463

With COVID-19, the 2019-2020, South Narrabeen's season abruptly ended without much fan-fare...

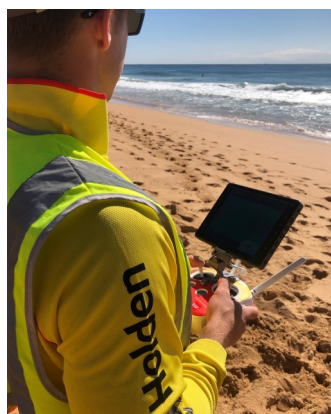
As a result, the number of awards dropped as compared to previous seasons. Despite the short-en season we have a number of members who earned significant awards this season as shown in the following table:

# FINANCE REPORT

I'm pleased to be presenting the financial statements of South Narrabeen SLSC for the year ended 30th April 2020 for the first time as Finance Director.

The following were the highlights:

The Net Current Year surplus was \$13,580

Income was \$146,956 (including the facility development grant) down \$25,345 mainly due to reduced Bush to Beach donations and Ocean View Room income.

Expenses were \$147,931 down \$14,067 mainly due to reduced Bush to Beach surplus provision and reduced depreciation.

## **Kiosk/Cafe**

The kiosk operated with a reduced rent in April due to Covid-19 however still contributed \$28,081 in income for the Club.

## **Donors and Grants**

A full list of all donors, sponsors, grant income and gift income is included in the detailed income statement notes.

Significant contributions included:

- Community Building Partnership. The Club utilised and received \$23,040 awarded in the 2018/19 year towards the build of the OVR awning.
- The club was awarded and utilised \$8,000 from the Department of Infrastructure and Transport on OVR improvements including flooring and painting.
- For the first time the club secured \$10,000 sponsorship from Channel 10.

## **Other Income Highlights**

- Membership subscriptions reduced as a result of the new fee structure reducing patrolling member fees to Nil, reducing Member subscriptions by \$2,500 to \$11,695.
- Unfortunately due to Covid-19 the Golf Day was called off.
- Club BBQ revenues were down as a result of reduced running of nippers from South Narrabeen due to beach erosion and shortened season due to Covid-19. This income was offset by some very well attended Nippers social events organised by the Nippers Social Committee.
- Hall Hire was significantly down due to carpark, awning, entry and lift building works impacting access, income was \$7,526.

## **In summary**

Despite some negative impacts on income during the 2019/20 year the club remains in a sound financial position with cash on hand of \$133,432.

Excluding the facilities development grant the clubs current assets of \$147,340 far exceed total liabilities of \$12,207 further supporting the clubs strong financial position.

The Club's equity position (member's funds) stands at \$518,303. This figure is representative of the amount of capital investment the committee has made over the past 10 years and continues to make, in improving building, gear and equipment, plus cash available after you take into consideration its debts.

I wish to recognise and thank Tim Davidson of Fortunity Assurance for auditing our accounts.

## **First year Finance Director observation**

I have been very impressed with the passion, commitment and tireless work put into running and improving our club by the Committee and other members who go above and beyond without question.

Clearly, as with any club environment, everyone who contributes is a volunteer, and the more volunteers keen to get in and get involved not only eases the workload, but also enables further improvement to our club and increase the contribution it makes to our community. I encourage all members interested in contributing some time to seek out a member of the committee that you know or one who is responsible for an area of interest as we would all appreciate your support. I must recognise and acknowledge the strong financial position and tidy state of financial affairs handed over to me by Charles Longley. It is clearly an organisation which recognises and drives commercial sound operations safeguarding the club and its members against financial risk. Charles' support has been fantastic, and I have very big shoes to fill!
