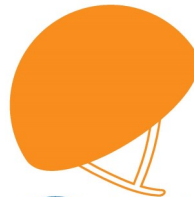
## **Club Objectives**

- To acquire or otherwise deal with land, buildings, leases, personal property, interests or rights with the object of furthering the interests of the Club.
- To carry on any other activities whatsoever calculated directly or indirectly to enhance further the interests of the Club such that profits are expended in furtherance of these Objectives only.
- To strive for governmental and public recognition of Surf Life Saving as the authority on aquatic safety.
- To promote the health and safety of members and users of the aquatic environment.

# PRESIDENT'S REPORT

This season it seems we have had everything thrown at us. In September, what could have been a grand Club opening, was impacted by the last phase of the front construction works . Then large swells wiped out our beach on several occasions closing the beach and preventing the ATV safe access. Then the drought, fires and the flooding in Narrabeen was followed by the Covid 19 closure which prematurely stopped all operations, meetings and events .

We started the season without a beach. As this photo shows the erosion was significant. So much so that it revealed for the first time the reef that lies beneath our beach.



6<sup>th</sup> September 2020

Without any sand replenishment available from Narrabeen Lagoon as in previous years, we had to wait for natural currents to restore the sand again. So we started the season in September considering options to relocate the Patrols north of the Club, past the Marquesas.

However, a series of swells returned sufficient sand and the council assisted with moving sand to create the correct profile .

Then, just when the beach was looking great there was a Covid outbreak centred on Avalon. A quarantine section was declared north from the Narrabeen bridge for 3 weeks from 19/12. However we bounced back when the quarantine was lifted and Australia Day became one of our busiest beach days on record.

Club membership was 147 members and we had 39 Nippers registered. Thanks to everyone on our Nippers Committee for their hard work in making South Narrabeen such a welcoming, safe and inclusive Club to be a part of.

And now 3 out of 4 major building works have been completed and the 4<sup>th</sup> will start in 2022 to avoid a repeat of building work at the start of the next Patrol season. The combined cost of these 4 building works now exceeds \$1.2m.

I can't stress enough the importance of getting these matters right before the steel and concrete goes in.

# ADMINISTRATION REPORT

The South Narrabeen Surf Life Saving Club committee met at the club on the second Tuesday of each month at 6.30pm. With the help of Technology (Zoom) we have been able to continue to meet via video conferences throughout the COVID Period. Been able to attend a meeting from the comfort of your lounge room on a cold winters evening has it's benefits.

IT related capabilities were a key focus from an Administration perspective. We have switched over to a new email platform based on Microsoft 365. This will support a number of important initiatives, including

- Centralised location for all Club documents and correspondence
- Ability to send and receive emails to a club (director level) email account v's emails using personal email accounts
- Significant increase in club electronic / digital storage
- Ability to access all emails and documents from any device.

The club has also engaged the services of a virtual receptionist. This meant that we needed to change the clubs phone numbers, whilst we were concerned about the potential impact of doing this, in reality it was a seamless transition. When ringing the club now the phone will always be answered, the purpose of the call will be assessed by the Virtual Receptionist and directed to Functions, Lifesaving, Membership, education or Admin.

Our club runs solely on the commitment and dedication of volunteers. As we move into the 2021-2022 season we will look to double down on ways to grow our membership and retain our existing members. With the building program well underway, we have kicked off our strategic planning for the coming years with a focus on "Recruitment and Retention". To achieve this we are focusing on three core areas, Members Services, Junior Activities and Surf Sports. We would love to hear from all members on their ideas and welcome anyone wishing to contribute to these areas.

I would like to extend my special thanks and ongoing support from to my fellow committee members for your energy and providing support around many administrative tasks.

Finally, I would like to thank Martin Hayward as he steps down from the club committee after many years of service.

We have a Amazing Club to administer and manage and it's imperative we do so to continue to fulfil our lifesaving commitments and to benefit the majority of our members and the community.

# **BUILDING REPORT**

Your committee is continuing the process of further developing our building to meet the ever-increasing requirements of Surf Life Saving and our members.

Over the past twelve months with the assistance of Northern Beaches Council we have demolished the “shark tower” and the beach side entrance stairs to the Restaurant and Ocean View Room. These have been replaced with an extension to the balcony and new stairs. During the reconstruction of this area a new all-weather awning was added along with the retiling of the balcony and new balustrades.

These works have certainly opened up and brightened the interior of the Ocean View Room this along with easier access to the Restaurant. This works also increased the outdoor seating for Restaurant.

The next stage in the refurbishment of the Club House will be the construction of the purpose built Education Room/Museum with a separate entrance. These works will commence early in the Financial Year 2021-2022 and should be completed by the opening of the 2021-2022 season.

Your Committee is also working with Northern Beaches Council to further the increase food storage areas for the Restaurant and equipment storage for the club. These works should be completed by the end of 2021.

I would like to thank Rob Stokes MP and the NSW Government for their financial support for these projects. I also thank Northern Beaches Council for the support and help by their staff in assisting to construct these works and also the maintenance staff for their continued help in attending any time we have a problem to rectify the issue.

We are close finalising our new twenty-year lease on the club building. The negotiations between Northern Beaches Council, Sydney Northern Beaches Branch have been going on for over two years, our present lease expired in August 2020.

Council has provided our club with a letter of comfort allowing us to continue to operate under the previous lease.

Northern Beaches Council is in the process of fitting Closed Circuit Television to the club for the safety and protection of our members and community.

Your Committee has worked very hard to update the facilities, especially Martin Hayward, Richard Dowling and Charles Longley.

To Charles Longley, I thank you for your assistance and support over the years. You are always there to fix, clean, greet customers, receive delivery's and above all support South Narrabeen SLSC.

# FINANCE REPORT TBC

I'm pleased to be presenting the financial statements of South Narrabeen SLSC for the year ended 30th April 2021 as the outgoing Finance Director. You will note a change to the format of the report. The format adopted is based on the requirements of the Australian Charities and Not-for-Profits Commissions Act 2012, Associations Incorporation Act 2009 and Charitable Fundraising Act 1991.

The following were the highlights within the report:

The net deficit for the year was \$(43,286).

Income was \$358,276 (including the facility development grant \$229k) up \$171k mainly due to the year-on-year increase in the facility development grant revenue received 206k, offset by:

- Reduced Grants and Donations \$(10k)
- Reduced Memberships \$(6k)
- Reduced Rental \$(16k) (last year included the writeback of café component rent \$15k)

Expenses were \$401,562 up \$228k mainly due to an arrangement with Northern Beaches Council where the council assumed responsibility for the stairs, deck and training room capital works in return for the unutilised facility development grant funds of \$229k. This resulted in an expense in the Profit and Loss of \$229k for these works in the current year, which ordinarily would have been treated as a fixed asset in the statement of Financial Position / Balance Sheet.

As part of the capital works performed during the year it was necessary to demolish the existing balcony awning. As such a write-off of the written down value of the awning was necessary for accounting purposes. This has resulted in the \$35k Loss on Sale of Non-Current Asset disclosed in the Profit and Loss.

## Kiosk/Café

The kiosk operated with a reduced rent from May to August due to Covid-19 however still contributed \$26,224 in income for the Club.

In addition to the above the remaining \$228,380 of the Community Building Partnership Facilities Development Grant was utilised on major capital works.

## **Other Income Highlights**

- Membership subscriptions reduced mainly due to Nipper memberships reducing as a result of COVID interruptions. Down by \$5k to \$6,401.
- Hall Hire was down \$5k due to Covid-19 interruptions as were social functions / occasions resulting in reduced functions revenue. Down 10k to \$18,389.

## **In summary**

The deficit of \$(43k) is a variance of \$(57k) as compared to the 2020 surplus of \$14k which was mainly due to:

- additional costs due to an accounting requirement to write off the balcony awning works \$35k
- reduced revenues recognised in 2020 relating to the facility development grant \$23k

It is important to note that Cash and Cash equivalents remained reasonably constant closing at \$135k. The reason that cash did not reduce despite the Profit and Loss resulting in a significant deficit \$(43k) is due to:

- Depreciation \$54k and Loss on Sale \$35k expenses not having a cash impact
- New fixed asset purchases \$(49)k

Despite some negative impacts for a 2<sup>nd</sup> year in a row the Club remains in a sound financial position with cash on hand of \$134,624.

The Club's current assets of \$145,736 far exceed total liabilities of \$13,550 further supporting the clubs strong financial position.

The Club's equity position (member's funds) stands at \$475,017.

## Thanks

In a year where the Club's café rental and function hire income has been negatively impacted by the Covid-19 pandemic, contributions from i) local, state and federal governments, ii) commercial business contributions and iii) individual donations have been critical to the club maintaining its financial standing.

I along with the club Committee and the club Members wish to thank those individuals, businesses and organisations who made financial donations and donations in-kind. Your support is very much appreciated and has helped our Club enormously.

I wish to recognise and thank Adrian Thompson and Drew Ridge of Fortunity Chartered Accountants for auditing our accounts.

## Outgoing Finance Director comment

I remain extremely impressed with the passion, commitment and tireless work put into running and improving our club by the Committee and other members who go above and beyond without question.

I have stepped down as Finance Director to more actively support with the Nippers Program. I have handed responsibility to Alan Brightman who has taken on the role with energy and a positive proactive approach which I expect will serve the Club well going forward.



### Notes To The Financial Statements For The Financial Year Ended 30 April 2021

#### 1. Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Australian Charities and Not-for-profits Commission Act 2012*, the *Charitable Fundraising Act 1991* and associated regulations. The committee has determined that the association is not a reporting entity.

South Narrabeen Surf Life Saving Club Incorporated is an association registered under the *Associations Incorporations Act 2009* and domiciled in New South Wales.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

These are special purpose financial statements that have been prepared for the purpose of complying with the *Australian Charities and Not-for-profits Commissions Act 2012* and associated regulations. The Executive Committee have determined that the accounting policies adopted are appropriate to meet the needs of the members of the South Narrabeen Surf Life Saving Club Inc.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the AASB and the disclosure requirements of AASB 101 'Presentation of Financial Statements'; AASB 107 'Statement of Cash Flows'; AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors'; AASB 1048 'Interpretations of Standards' as appropriate for not-for-profit oriented entities.

#### Accounting Policies

##### Revenue

Revenue is recognised when it is probable that the economic benefit will flow to the company and the revenue can be reliably measured.

##### *Sale of goods*

Sale of goods revenue is recognised at the point of sale, which is when the customer takes receipt of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract. Amounts disclosed as revenue are net of sales returns and discounts.

##### *Functions and Events*

Revenue from functions and events are recognised once the event is held in the Club facilities and has meet its obligations to provide a venue for the expressed purpose agreed with the parties.

##### *Membership fees*

Revenue from membership fees is recognised at time of receipt.

##### *Grants and donations*

Grant & donation income is recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

##### *Interest*

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

**Inventories**

Inventories are measured at the lower of cost and net realisable value.

**Plant and Equipment / Surf Patrol Equipment**

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount and impairment losses are recognised in the profit or loss as revaluation decreases if the impairment losses relate to the revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

**Depreciation**

The depreciable amount of all fixed assets, including buildings and capitalised lease assets is depreciated on a straight line or diminishing-value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

<b>Class of Fixed Asset</b>	<b>Depreciation Rate</b>
Plant and Equipment	22.5%
Leasehold Improvements	10 - 22.5%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These gains or losses are recognised in profit or loss in the period which they arise. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

**Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

**Goods and Services Tax**

Revenues, expenses and assets recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included in other receivables or payables in the statement of financial position.

**Income Tax**

As the company is a charitable institution in the terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

**Trade and Other Payables**

Trade and other payables represent the liabilities for goods and services received by the company during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

**Comparative Figures**

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

**Critical Accounting Estimates and Judgements**

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

Robert Charles Ferguson, known universally as “Dunlop”, joined South Narrabeen SLSC at age 16, gaining his Bronze Medallion on 31<sup>st</sup> December 1956. His genial and kindly nature ensured that he became one of the most popular and well known of men in our entire district, not only through his participation in the surf club movement but also in rugby league, wrestling, jet boat surf rescue and more. Standing at 198 cm and weighing in at 120 kg in his prime he is well remembered by his many friends from all walks of life as a gentle giant.

He was a great worker around our club, always willingly helping and leading wherever needed; in all aspects both in the surf and on the committee and in patrolling and mentoring of younger members. More than that he was brave and took part in some notable rescues,

He was also one of the Jet Rescue Boat pioneers on the Northern Beaches when he skippered the “Paul Jackman” Boat at Fisherman’s Beach. Dunlop was at the helm when a number of notable rescues were performed in big surf off Long Reef.

Bob was a good competitor for South Narrabeen in the Senior Rescue and Resuscitation, Surf Boat and March Past events and to round it off for a bit of fun he would go in for surf carnival novelty contests such as the Pillow Fight and Chariot Race to the great amusement of the crowd.

Well-deserved Life Membership was bestowed on Robert Charles Ferguson in 1974 for all of his activities at South Narrabeen.

Dunlop is well remembered by friends from many walks of life as “one of the best” and as a man whose heart has never left South Narrabeen Surf Club.
